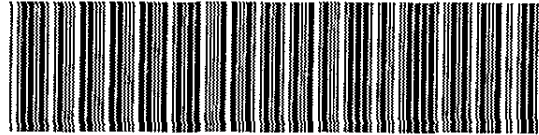

Authorization to Dissolve




