

ARTICLES OF INCORPORATION FOR

JANE E. WOLFE, P.A.

THE UNDERSIGNED NATURAL PERSON, for the purpose of forming a professional corporation under the Florida Professional Service Corporation and Limited Liability Company Act, hereby adopts the following Articles of Incorporation.

ARTICLE I

Corporate Name and Principal Office

The name of the corporation shall be: JANE E. WOLFE, P.A. (the "Corporation"), and the mailing and street address of the Corporation's principal office shall be located at 141 Divi Divi Drive, San Mateo, FL 32187.

ARTICLE II

Nature of Business
