**ARTICLES OF INCORPORATION
FOR
JANE E. WOLFE, P.A.**

THE UNDERSIGNED NATURAL PERSON, for the purpose of forming a professional corporation under the Florida Professional Service Corporation and Limited Liability Company Act, hereby adopts the following Articles of Incorporation.

ARTICLE I

Corporate Name and Principal Office

The name of the corporation shall be: JANE E. WOLFE, P.A. (the "Corporation"), and the mailing and street address of the Corporation's principal office shall be located at 141 Divi Drive, San Mateo, FL 32187.

ARTICLE II

Nature of Business

This corporation is organized for the following purposes:

- a. To provide services as a real estate agent, broker, and consultant. Providing such services are the sole and exclusive professional services to be rendered by this corporation.

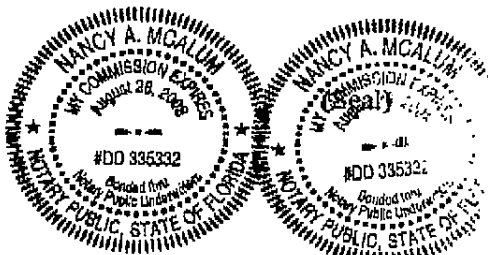

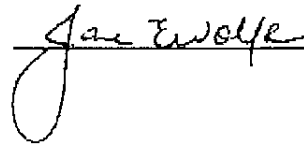
