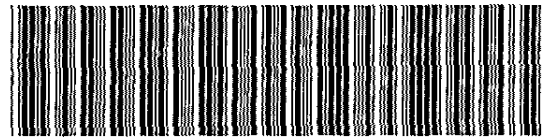

ARTICLES OF INCORPORATION

ARTICLE I - NAME

The name of this corporation is SUELFERR USA, Inc.

ARTICLE II - PRINCIPAL OFFICE
