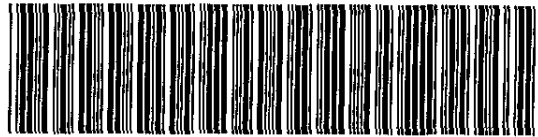

ARTICLES OF INCORPORATION

OF

The Undersigned, all of whom are eighteen (18) years or older, for the purpose of forming a common stock corporation under the general law of the State of Florida certify:

ARTICLE I
