
**ARTICLE XI - AMENDMENT**

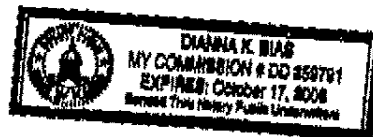


