CHANGE OF REGISTERED AGENT/REGISTERED OFFICE:

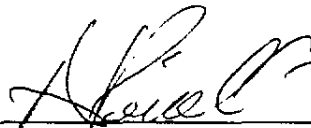
Antonio Ricolt is hereby deleted as the Registered Agent of the corporation.

The Amended Articles were adopted by a majority of the Corporation's Directors/Shareholders.

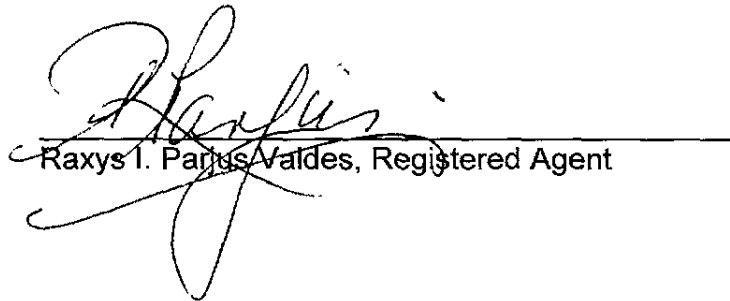
