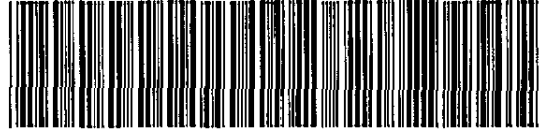

**ARTICLES OF INCORPORATION**  
**OF 80 PROOF RECORDS INC.**  
**A FLORIDA PROFIT CORPORATION**

**Article I:**

The name of the Corporation shall be **80 Proof Records Inc.**

**Article II:**

The principal place of business and mailing address of the Corporation shall be 879 Derbyshire Road, Daytona Beach, Florida 32117.

**Article III:**

The purpose for which the corporation is organized is exclusively for record distributions and entertainment purposes.
