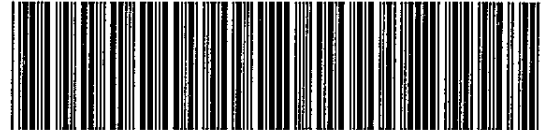

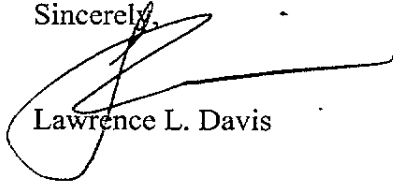

ARTICLES OF AMENDMENT
OF
PEER GROUPING REPORTS, INC.

The undersigned, as chairman of the board of directors of PEER GROUPING REPORTS, INC., a Florida corporation under the Florida Business Corporation Act, Chapter 607 of the Florida Statutes, files these Articles of Amendment to the Articles of Incorporation on behalf of such Corporation:

ARTICLE I
NAME
