ARTICLES OF INCORPORATION
OF
NANCY DISTLER, A.P., P.A.

The undersigned hereby makes and subscribes to these Articles of Incorporation intending to form a professional service corporation (the "Corporation") under the provisions of the Florida Statutes.

ARTICLE I - NAME

The name of this Corporation is NANCY DISTLER, A.P., P.A.

ARTICLE II - PURPOSE

The Corporation may engage in every phase and aspect of the business of rendering the same professional services to the public that an acupuncturist and herbologist, duly licensed under the laws of the State of Florida, is authorized to render, but such professional services shall be rendered only through officers, employees and agents who are duly licensed acupuncturists and herbologists in the State of Florida.

The Corporation shall not engage in any business other than the practice of acupuncture and herbology. However, this Corporation may invest in real estate, mortgages, stocks, bonds or any other type of investment, and may own real and personal property necessary for the rendering of the professional services authorized hereby.

The Corporation shall have all the powers conferred upon this Corporation by the laws of the State of Florida or of any other state or country not prohibited by the Professional Service Corporation Act.

ARTICLE III - SHARES

The aggregate number of shares which the Corporation shall have the authority to issue shall be 10,000 at \$1.00 par value common shares.

ARTICLE IV - PRINCIPAL OFFICE AND MAILING ADDRESS

The initial principal place of business and mailing address of the Corporation shall be 326 East Palmetto Park Road, Boca Raton, Florida 33432.

ARTICLE V - REGISTERED AGENT

The name and Florida street address of the Corporation's initial registered agent is NANCY DISTLER, 326 East Palmetto Park Road, Boca Raton, Florida 33432.

ARTICLE VI - INITIAL DIRECTORS

The number of Directors constituting the initial Board of Directors of this Corporation is **One (1)**. The number of directors may be either increased or decreased from time to time as provided in the Bylaws of the Corporation, but shall never be less than one (1). ARTICLE VIII - INDEMNIFICATION

It is the intention of the Corporation to indemnify its Officers, Directors, employees and agents to the extent permitted by Section 607.0850, Florida Statutes.

ARTICLE IX - CORPORATE BUSINESS AND AFFAIRS

Anything to the contrary contained in these Articles of Incorporation notwithstanding, if the Shareholders of the Corporation shall so elect, they may exercise all powers and conduct the business and affairs of this Corporation in lieu of the Board of Directors.

ARTICLE X - RESIDENCY AND COMPENSATION OF DIRECTORS

Directors of this Corporation need not be residents of the State of Florida, unless otherwise provided in the By-Laws of the Corporation.

The Shareholders of this Corporation shall have exclusive authority to fix the compensation of Directors of this Corporation, unless otherwise provided in the By-Laws.
