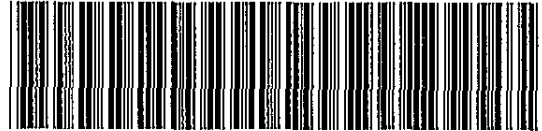

**ARTICLES OF INCORPORATION
OF
KRISTINE A. SMITH, P.A.**

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act do hereby adopt the following articles of incorporation:

ARTICLE I

The name of this Corporation is: KRISTINE A. SMITH, P.A.

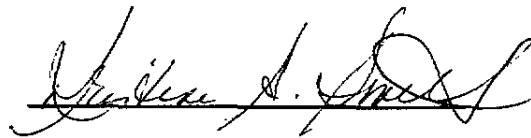
ARTICLE VIII

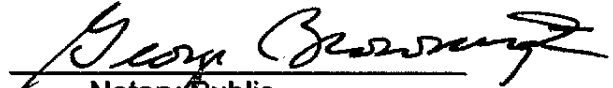

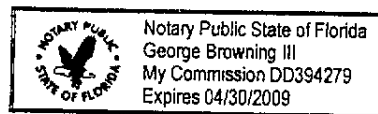

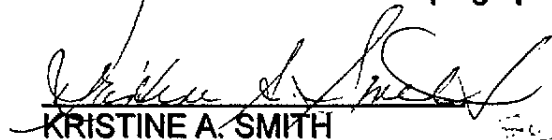
