I am writing this letter on behalf of my client listed above in regards to payment of their annual filing fee of \$150 that was due on May 1, 2007.

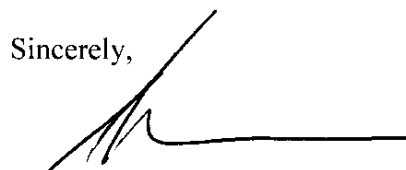
Please be advised that my client has not received the reminder postcard from the Department of State. He did however receive the Notice to Dissolve.
