ARTICLE I - NAME AND ADDRESS

The name of this corporation is **CUSTOMER CONTACT MANAGER GP, INC.** (the "Corporation"). The address of the principal office and the mailing address of the Corporation is 1200 S. Pine Island Road, Suite 200, Plantation, Florida 33324.

ARTICLE II - PURPOSE

ARTICLE IX - INDEMNIFICATION

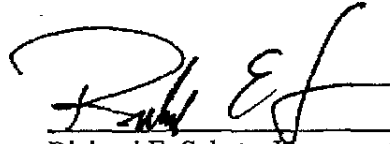
The Corporation shall indemnify any officer or director, or any former officer or director of the Corporation, to the fullest extent permitted by law.

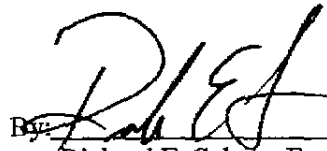
