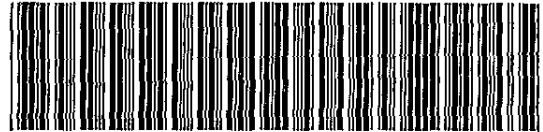

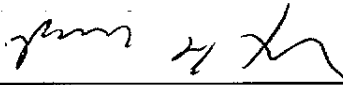

In compliance with the requirements of F.S. Chapter 607 and/or Chapter 621, F.S. (Profit), the undersigned hereby act as incorporators in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

ARTICLE I
