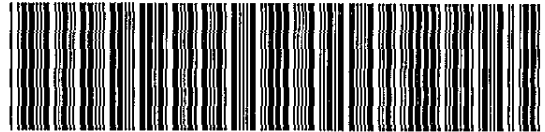

ARTICLE I - NAME

THE NAME OF THIS CORPORATION IS:

BEST ADVANTAGE CLEANING INC.

ARTICLE II - DURATION

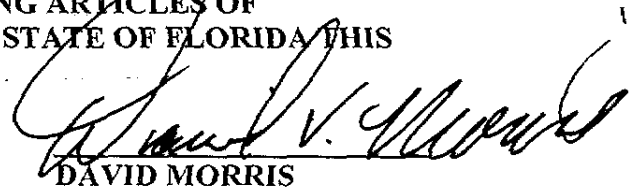
ARTICLES XI – PRE-EMPTIVE RIGHTS

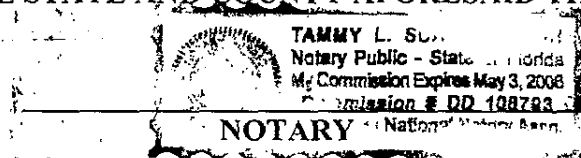

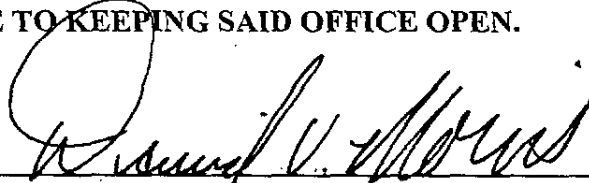

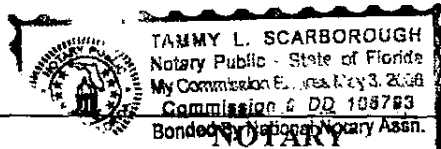
