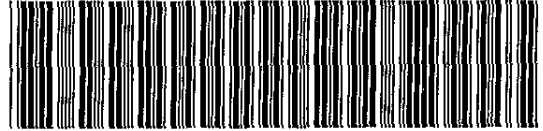



ARTICLES OF INCORPORATION
OF
ARTHUR CHRISTIAN HILMER CO.

The undersigned, desiring to form a corporation for profit under the laws of the State of Florida, hereby certifies: STATE
TALLAHASSEE, FLORIDA

FIRST: The name of the corporation shall be:

ARTHUR CHRISTIAN HILMER CO.

SECOND: The place in Florida where its principal office is to be located is: 37 N.W. 1st Street, Homestead, Florida 33030.

THIRD: The purpose for which the corporation is formed is to engage in any lawful act or activity for which corporations may be formed under the laws of the State of Florida.

FOURTH: The maximum number of shares which the corporation is authorized to have outstanding is FIFTEEN HUNDRED (1,500) shares which shall consist of:

- (a) THREE HUNDRED (300) shares shall be Class "A" common shares, \$.01 par value, and shall possess all of the voting rights of the corporation as hereinafter determined; and
- (b) TWELVE HUNDRED (1,200) shares shall be Class "B" common shares, \$.01 par value, and shall be non-voting.
- (c) The express terms of the shares of each class are as follows:
 - (1) No dividends shall be declared or paid on any class unless at the same time there shall be declared or paid, as the case may be, a dividend in the form of cash or property in an equal amount per share on the other class;
 - (2) In the event of a share dividend the dividend shall be payable in the same class;
 - (3) No holder of shares of the corporation shall have a preemptive right to subscribe for or to purchase any shares of any class of the corporation whether now or hereafter authorized; and
 - (4) Each class of shares shall be treated equally upon the dissolution, termination or winding up of the corporation.


FIFTH: The amount of stated capital with which the corporation shall begin business is Five Hundred (\$500) Dollars.

SIXTH: The registered agent shall be: Arthur Christian Hilmer, 37 N.W. 1st Street, Homestead, Florida 33030.

SEVENTH: The incorporator is: Arthur Christian Hilmer, 37 N.W. 1st Street, Homestead, Florida 33030.

EIGHTH: The corporation may purchase its own shares on prorata and/or non-prorata basis when authorized to do so by its Board of Directors.


