ARTICLES OF INCORPORATION OF MIRAMAR CONSULTING OF N.W. FLORIDA, INC.

The undersigned subscriber, being the incorporator of these Articles of Incorporation, hereby forms a corporation under the laws of the State of Florida, Florida Statutes, Chapter 607 as follows:

ARTICLE I

The name of this corporation is MIRAMAR CONSULTING OF N.W. FLORIDA, INC.

ARTICLE II

This corporation shall exist perpetually.

ARTICLE III CORPORATE PURPOSE AND POWERS

This corporation is organized for the purpose of conducting any and all lawful business not in conflict with the Statutes of the State of Florida.
