These Articles of Correction correct the Articles of Merger and Plan of Merger of Meridian Broadcasting, Inc. into Sun Broadcasting, Inc., filed with the Department of State on December 29, 2011.

The inaccuracies, incorrect statements, or defects are in the Plan of Merger as follows:

Article Third, Section D in the fourth line incorrectly names the entity that will assume the liabilities and obligations of the merged entity.

Article Third, Section E inaccurately describes the Shareholders who will become the Shareholders of SUN.

Article Fourth, Section A inaccurately describes the Shareholders who will become the shareholders of SUN.

Corrections to the inaccuracies, incorrect statements or defects in the Plan of Merger are as follows:

*In Article Third, Section D, the word "SUN" in the third sentence should be changed to "MERIDIAN".*
