CERTIFICATE OF INCORPORATION

OF

WE, the undersigned, do hereby associate ourselves together and subscribe this Certificate of Incorporation for the purpose of forming a corporation under the laws of the State of Florida, and subject to the following provisions:

ARTICLE ONE

The name of the corporation shall be **ERNESTO RODRIGUEZ HURRICANE SHUTTERS PROTECTION, INC.**

ARTICLE TWO

The corporation may engage in any activity or business permitted under the laws of the United States of America and of the State of Florida.

ARTICLE TWELVE

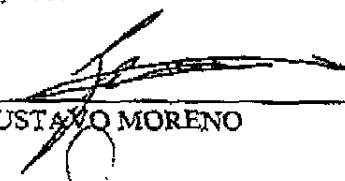

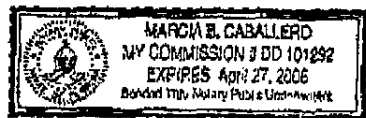

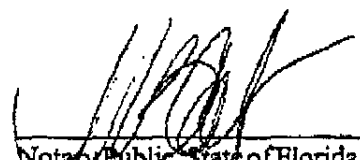
