FINAL JUDGMENT OF DISSOLUTION OF MARRIAGE

THIS CAUSE came on to be heard for the Final Hearing upon the Petition for Dissolution of Marriage, and the Court being otherwise advised in the premises, and on the evidence presented, makes the following findings of fact.

1. This court has jurisdiction of the parties and the subject matter.

The parties were married to each other on May 5, 1981 in Puerto Rico.

2. The Petitioner/Husband is a bona fide resident of Broward County, Florida.
3. The Respondent/Wife is a bona fide resident of Broward County, Florida.
4. The marriage is irretrievably broken.
5. Each party is desirous of being restored to the status of being single and unmarried.
6. There are no minor children and none are contemplated.
7. The parties have voluntarily entered into a Marital Settlement Agreement, a copy of which is attached hereto as Exhibit "A."
8. The marriage between the parties is dissolved and each spouse is restored

to the status of being single because the marriage is irretrievably broken.

9. The parties' have equitably distributed all marital assets and liabilities.

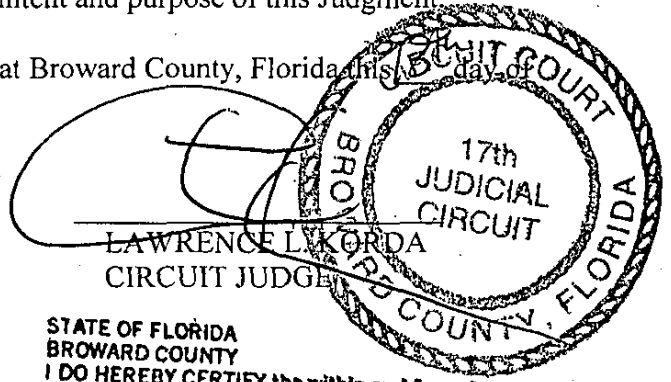
10. Qualified Domestic Relations Orders ("QDRO's") have been prepared by Janen Moyer & Co. which QDRO's were approved by Exxon Mobil Corporation on December 20, 2005.

11. The Marital Settlement Agreement between the parties dated the 24<sup>th</sup> day of January, 2006, and introduced into evidence is facially fair and was executed voluntarily and after full disclosure and is in the best interest of the parties. Further, each party is to take each and every reasonable and necessary action and conduct themselves in such manner as to carry out the intent and purpose of this Judgment.

13. Petitioner's name shall be changed to Rodriguez.
