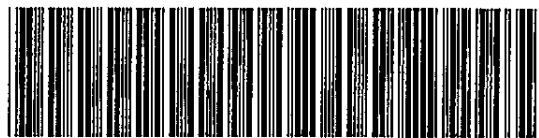

ARTICLES OF INCORPORATION

OF

ARTICLE ONE:

The name of the corporation is: Med to Med, Inc.

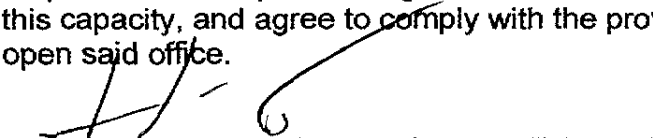
