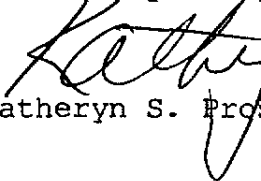

**ARTICLES OF INCORPORATION
OF
CREATIVE GLASS ARTISTS, INC.**

ARTICLE I: The name of this corporation is **CREATIVE GLASS ARTISTS, INC.**

ARTICLE II: This corporation shall have perpetual existence.

ARTICLE III: This corporation is organized for the purpose of engaging in any activity or business permitted under the laws of the United States or the State of Florida.

ARTICLE IV: The maximum number and class of shares of capital stock which this corporation is authorized to have outstanding is one hundred shares of common capital stock with a par value of One Dollar (\$1.00) per share.

ARTICLE V: The initial principal office of this corporation shall be at, 1877 Mealy Street South, Atlantic Beach, Florida 32233, and the name of the corporation's initial registered agent at that address is KIRK REBER.

ARTICLE VI: Initially, this corporation shall have one member on the Board of Directors. The number of directors may be increased or decreased from time to time by Resolution of the shareholders, but at no time shall there be less than one member on the Board of Directors. ARTICLE VIII: The power to adopt, alter, amend or repeal Bylaws shall be vested in the Board of Directors and the shareholders.

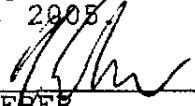
ARTICLE IX: The Directors of this corporation shall take action by written consent, as provided by law.

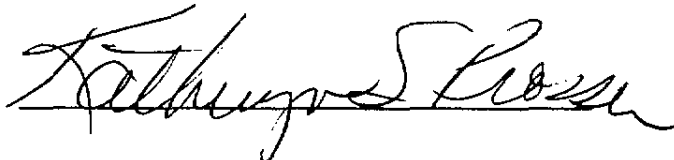
