

ARTICLE I. NAME

The name of this corporation shall be HAYGOOD AIR CONDITIONING, INC.

ARTICLE II. COMMENCEMENT & DURATION

The commencement of this corporation's existence shall be at the time of the filing of these Articles Of Incorporation by DONALD RAY HAYGOOD, SR., the incorporator. This corporation's duration shall be perpetual.
