ARTICLES OF INCORPORATION OF

The undersigned subscriber to these Articles of Incorporation hereby forms the corporation under the laws of the State of Florida, as follows:

FIRST: The name of said corporation shall be BELLA MARE CORP., a Florida Corporation. The mailing address and the street address of the principal office of the corporation shall be: c/o: 1911 Harrison Street, Hollywood, Florida 33020.

SECOND: BELLA MARE CORP., a Florida Corporation, shall have a perpetual duration from the date of filing of these Articles of Incorporation.

THIRD: The sole purpose for which BELLA MARE CORP., a Florida Corporation, is formed is:

a) Holding and owning real estate property, selling, managing and holding such real estate properties.


Designation and Acceptance of Registered Agent
