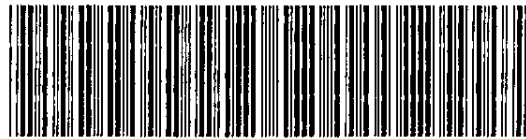

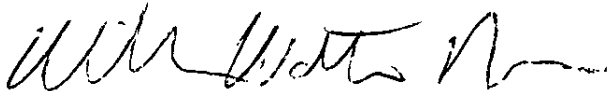

Pursuant to the provisions of section 607.1006, Florida Statutes, this Florida profit corporation adopts the following amendment to its Articles of Incorporation:

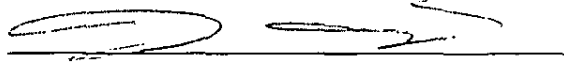
FIRST: Article I. of the Articles of Incorporation of this corporation is amended in its entirety to read as follows:
