ARTICLES OF INCORPORATION
OF
T&S OF SOUTH CAROLINA, INC.
(a Florida corporation)

Pursuant to Florida Statutes Section 607.0201, the undersigned hereby submits the following Articles of Incorporation of T&S OF SOUTH CAROLINA, INC., a corporation being organized under the laws of the State of Florida.

ARTICLE I.
Name

The name of the Corporation is "T&S OF SOUTH CAROLINA, INC." (hereinafter called the "Corporation").

ARTICLE II.
Purpose

The Corporation is formed to engage in any lawful act or activity for which corporations may be organized under the Florida Business Corporation Act, Chapter 607, Florida Statutes (the "FBCA"), including any amendments thereto.

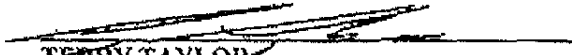
