The undersigned incorporator to these Articles of Incorporation hereby forms a corporation under the laws of the State of Florida as follows:

ARTICLE I Name and Address

Term of Existence

Term of Existence

This Corporation shall have perpenual existence, commencing upon the filing of these Articles of Incorporation with the Fiorida Secretary of State.

ARTICLE III Purpose

This Corporation is organized for the purpose of transacting any and all lawful business.
