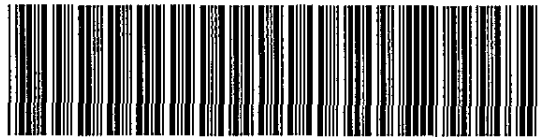

ARTICLES OF INCORPORATION
OF

ARTICLE I

The name of this corporation is BOOKITOUT, INC.

This Corporation shall have perpetual existence, unless sooner dissolved according to law.

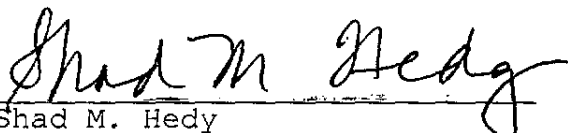

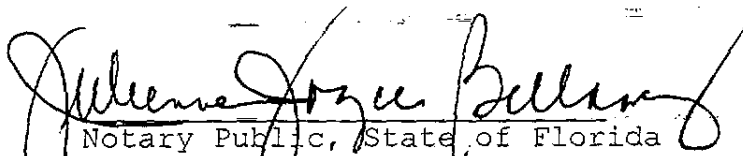
