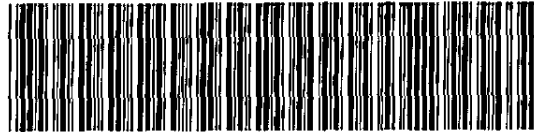

**ARTICLES OF INCORPORATION

The undersigned incorporators to these Articles of Incorporation, natural persons over the age of 18 years, competent to contract and the majority of who are citizens of the United States of America, hereby form a stock insurer corporation under the laws of the State of Florida.

ARTICLE I. NAME

The name of the corporation shall be: AMERICAN TRADITIONS INSURANCE COMPANY The initial principal place of business shall be: 12000 28th Street, Second Floor, Saint Petersburg, Florida 33716

ARTICLE II. NATURE OF BUSINESS

The purpose of the corporation is to engage in every aspect of property and casualty insurance and any lawful act or activity incidental thereto.

ARTICLE III. CAPITAL STOCK

The maximum number of shares that this corporation is authorized to issue is 1,000 shares of common stock having a par value of \$1 per share. The corporation shall not begin transacting business unless it achieves a capital surplus of \$5 million.

ARTICLE IV. TERM OF EXISTENCE

The corporation shall exist perpetually.
