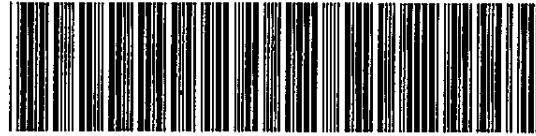


ARTICLE 7 - INITIAL BOARD OF DIRECTORS


