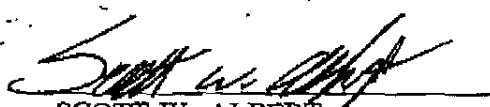

ARTICLE NINE. AMENDMENT

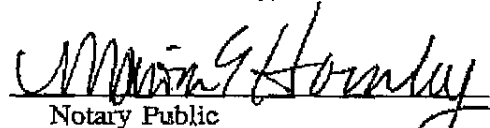
