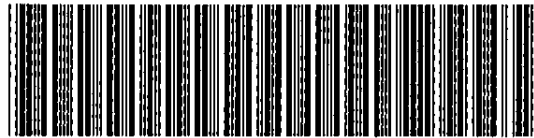

THE UNDERSIGNED duly authorized officer of Franklin Employer Solutions, Inc, a Florida corporation for profit (the "Corporation") organized under Chapter 607, Florida Statutes, hereby executes these Articles of Amendment for the purpose of amending the existing Articles of Incorporation of the Corporation, as permitted by Section 607.1006, Florida Statutes.

1. The name of the Corporation is Franklin Employer Solutions, Inc
2. The Amendments set forth in paragraph 3 below have been approved and adopted by the unanimous written consent of the Corporation's shareholders entitled to vote thereon taken on October 24, 2012, which vote was sufficient for approval.
3. Article IV has been amended in its entirety to read as follows:


**ARTICLE IV**

The capital stock of the corporation shall consist of (10,000) shares of voting capital common stock (no stated par value). In connection with each new or additional offering for sale or issuance of any shares of the stock of the corporation, each shareholder shall have the preemptive right to purchase a pro rata portion of such new or additional offered shares of stock.

4. Except as expressly amended hereby, the Articles of Incorporation shall be and remain in full force and effect. These Articles shall be effective upon filing with the appropriate office of the State of Florida, Department of State.
