ARTICLES OF INCORPORATION OF CARMEL MOVERS, INC.

ins oct 17 A Bas I, the undersigned, for the purpose of becoming a Corporation under the Laws of Florida, by and under the provisions of the Statutes of the State of Florida, providing to the formation, liabilities, rights, privileges, and immunities of corporations for profit, file these Articles of Incorporation.

ARTICLE I

The name of the Corporation is CARMEL MOVERS, INC.

ARTICLE II

The general nature of the business to be transacted is as follows:

To own, operate and maintain, acquire by SECTION 1: purchase, lease, or otherwise trucklines, and any other means of transportation for the transportation of freight, goods, wares, and other property of every kind of nature, and to conduct, engage in, and carry on the business of transportation of property of every class and description; and to own, operate, maintain, hold and use, purchase, lease, and sell, or otherwise dispose of or deal with terminal properties and storage facilities which may be necessary or useful in connection with the business of the Corporation and in general to do any and all acts that may be necessary, convenient, or appurtenant to any one of the above-mentioned objects or industrial enterprise calculated or designed to be profitable to this Corporation and in conformity with the Laws of the State of Florida.

SECTION 2: To generally engage in, do and perform any enterprise, act or vocation that a natural person might do or perform.

To engage in and carry on any business or SECTION 3: businesses and every act or deed pertaining thereto, either directly or indirectly, which is not prohibited by the Laws of the State of Florida, and to so engage in and carry on said business or businesses in Florida, or in any other State in the United States or in any foreign country. To do any and all things necessary, suitable, useful, proper or admissible for the accomplishment of any one of the purposes or for the attainment of any of the objects or further exercise of the powers herein set forth, whether herein specified or not, either alone or in connection with other firms, throughout the United States and elsewhere.

ARTICLE III

The foregoing clauses shall be construed both as objects

and powers, but no recitation, expression or declaration of specific or special powers or purposes herein enumerated shall be exclusive, but it is hereby expressly declared that all other lawful powers not inconsistent herewith are hereby included.

ARTICLE IV

Any unissued stock or such additional authorized issue of new stock or of other securities convertible into stock may be issued and disposed of pursuant to resolution of the Board of Directors to such persons, firms, corporations or associations and upon such terms as may be deemed advisable by the Board of Directors in the exercise of their discretion.
