ARTICLES OF INCORPORATION OF JASON L. HARR, P.A.

TALLAHASSEE, FLORIDA
The undersigned, acting as the sole incorporator, desiring to form a corporation for profit pursuant to the Florida Business Corporation Act, Chapter 607, Florida Statutes, adopts the following Articles of Incorporation:

ARTICLE I - NAME OF CORPORATION

The name of the corporation shall be JASON L. HARR, P.A.

ARTICLE II - GENERAL PROVISIONS

It is intended that the corporation is organized for and may conduct and transact any and all lawful business authorized and not prohibited by the Florida Business Corporation Act, as the same may be, from time to time, amended. Practice of Law

ARTICLE III - PRINCIPAL OFFICE

The principal office of the corporation in the State of Florida is: P.O. Box 12217, Daytona Beach, Florida 32120-2217.

ARTICLE IV - INCORPORATOR

ARTICLE V - INITIAL REGISTERED OFFICE AND REGISTERED AGENT

ARTICLE VI - TERM OF EXISTENCE

The corporation shall begin its corporate existence as of the filing of these Articles of Incorporation and shall exist perpetually.

<u>ARTICLE VII - CAPITAL STOCK</u>

The maximum number of shares of capital stock that the corporation is authorized to issue and have outstanding is One Hundred Thousand (100,000) shares which shall be designated as Common Shares with no par value.

The corporation shall, to the fullest extent legally permissible under the provisions of Florida Law, as the same may be amended and supplemented, indemnify and hold harmless any and all persons whom shall have power to indemnify under said provisions from and against any and all liabilities (including expenses) imposed upon or reasonably incurred by him in connection with any action, suit or other proceeding in which he may be involved or with which he may be threatened, or other matters referred to in or covered by said provisions both as to action in his official capacity and as to the action in another capacity while holding such office, and shall continue as a person who has ceased to be a director or officer of the corporation. Such indemnification may be entitled under any Bylaw, Agreement or Resolution adopted by the shareholders, entitled to vote thereon after notice.
