
**Amendment**

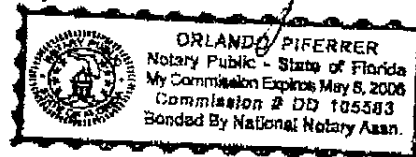
