We, the undersigned subscribers to these articles of incorporation, natural persons competent to contract, hereby form of Corporation under the Laws of State of Florida, <sup>2005 NOV -7 A 10: 06</sup> TALLAHASSEE, FLORIDA.

**ARTICLE I, NAME OF CORPORATION:**

The name of the Corporation shall be:

**L.C.A.E., CORPORATION.**

**ARTICLE II, GENERAL NATURE OF THE BUSINESS:**

The general nature of the business and the object and purposes to be transacted and carried on are.

To conduct any and all business not prohibited by the Laws of the United States and State of Florida.

To conduct business in, have one or more offices, DUCTWORK A/C. CLEANING SERVICES.

To purchase the corporate assets or any other Corporation and engage in the same or other character of business. of the State of Florida, or any other state government, and while owner of such stock to exercise all the rights, powers and privileges of ownership, including the right to vote such stock.

The initial place of business of said Corporation in this State shall be 1487 N.E. 180 STREET NORTH MIAMI BEACH, FL. 33162.



**ARTICLE VII, DIRECTORS:**




