**ARTICLES OF INCORPORATION (PROFIT)
OF
HISPANIC MARKETPLACE ORGANIZATION, INC.**

Thomas E. Ruiz , being of the age of eighteen (18) years old or more, does hereby make and acknowledge these Articles of Incorporation under and by virtue of the laws of the State of Florida.

- 1. The name of the Corporation shall be: Hispanic Marketplace Organization, Inc.**
- 2. The number of shares the corporation is authorized to issue shall be 500 shares all of one class designated as common stock, at \$1.00 per value.**
- 3. The street address and county of the initial principal office of the corporation is: 138 Seabreeze Circle, Kissimmee, Fl. 34743, Osceola County and the name of the initial register agent at this address is: Thomas E. Ruiz.**
- 4. The number of the directors constituting the initial Board of Director shall be two directors and the names and addresses of the persons whom are to serve as directors until the first meeting of shareholders or until their successors are elected and qualified is:**
 - Thomas E. Ruiz, Pres/Treasurer and the address is 138 Seabreeze Circle, Kissimmee, Fl. 34743**
 - Lidice Ruiz, VP, Sec. at the same address.**
- 5. To the fullest extent permitted by the State of Florida Business Corporation Act as it exists or may hereafter be amended, no person who is serving or who has served as a director of the corporation shall be personally liable to the corporation or any of its Shareholders for monetary damages for breach of duty as a director. No amendment or repeal of this Article nor the adoption of any provision of these Articles inconsistent with these Articles shall eliminate or reduce the protection granted herein with respect to any matter that occurred prior to such amendment repeal of adoption.**
