CHANGE OF REGISTERED AGENT:

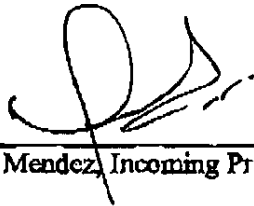
Oscar Gonzalez is hereby *deleted* as Registered Agent of the Corporation.
