Article V The name and Florida street address of the registered agent is CT Corporation System, 1200 South Pine Island Road, Plantation, Florida, 33324.

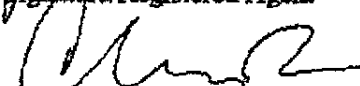
