ARTICLE I - NAME

The name of this Corporation is P. Quentin Baker, Inc.

ARTICLE II - DURATION

This Corporation shall have perpetual existence commencing on January 2, 2006.

ARTICLE III - PURPOSE

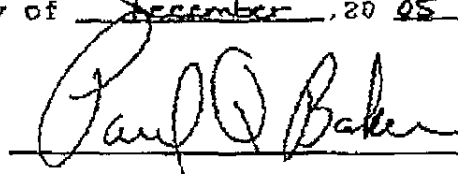
ARTICLE XI - BY-LAWS
