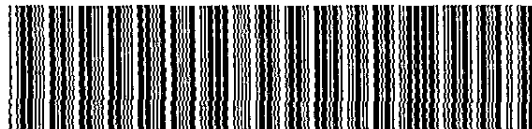

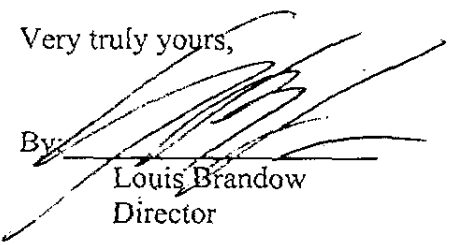

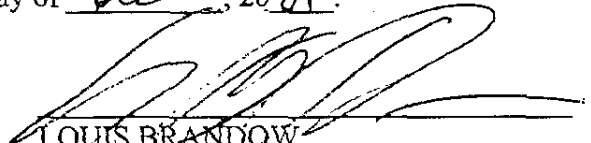
ARTICLE IX

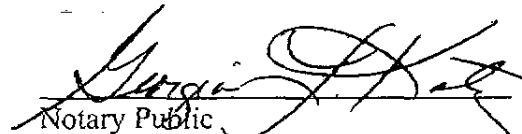

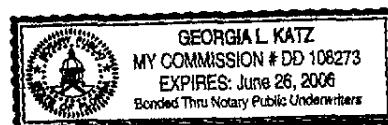

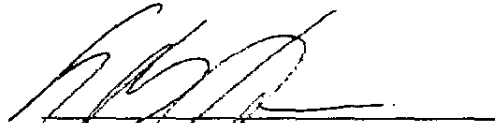
