The undersigned, acting as the incorporator of a corporation, under the laws of the State of Florida, Florida Statutes, Chapter 607, and hereby sets forth and declares:

CHARTER

Article I Name

The name of the corporation shall be J F Estates of SW Florida Inc

Article II Principal Office

The principal place for the transaction of the corporation business shall be 1832 SW 50th Terrace in the City of Cape Coral, County of Lee, in the State of Florida, 33914, and the mailing address is the same.
