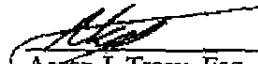

These Articles of Incorporation may be amended in the manner provided by law.

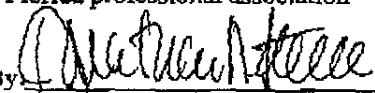
ARTICLE VIII
