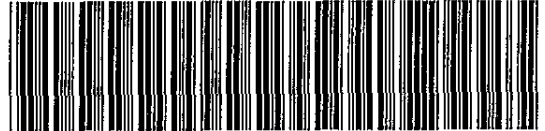

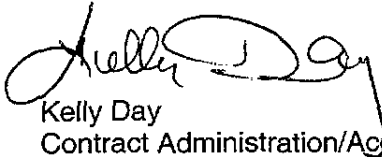

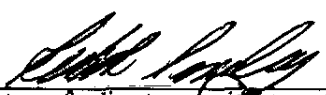

ARTICLES OF AMENDMENT

THIS IS TO CERTIFY THAT:

FIRST: Johnson, Mirmiran & Thompson, P.A., a Maryland corporation (the "Corporation"), hereby amends its charter as set forth in these Articles.

SECOND: Article 1 of the Corporation's charter is hereby deleted in its entirety; and, in place thereof, the following is inserted:

"1. The name of the Corporation (herein the "Corporation") is "Johnson, Mirmiran & Thompson, Inc."

THIRD: Article 6 of the Corporation's charter is hereby deleted in its entirety; and, in place thereof, the following is inserted:

"6. Notwithstanding anything in Section 3-105 of the Maryland General Corporation Law to the contrary, a transfer of assets described in Section 3-105(a)(3) of the Maryland General Corporation Law shall be effective and valid only if taken or authorized by the affirmative vote of stockholders holding at least seventy - five percent (75%) of all of the votes entitled to be cast thereon."

FOURTH: The amendment of the charter of the Corporation as set forth above has been duly advised and approved by a majority of the board of directors and was approved by the stockholders of the Corporation as required by law.

FIFTH: The undersigned President acknowledges these Articles of Amendment to be the corporate act of the Corporation and as to all matters or facts required to be verified under oath, the undersigned President acknowledges that to the best of the President's knowledge, information and belief, these matters and facts are true in all material respects and that this statement is made under the penalties for perjury.

IN WITNESS WHEREOF, the Corporation has caused these Articles to be signed in its name and on its behalf by its President and attested by its Secretary on November 28, 2001.
