CERTIFICATE OF AMENDMENT OF THE CERTIFICATE OF INCORPORATION OF MELBOURNE REINSURANCE CORPORATION

Under Section 242 of the General Business Corporation Law

The undersigned, being the President and Secretary of Melbourne Reinsurance Corporation, do hereby certify and set forth:

FIRST: The name of the corporation is Melbourne Reinsurance Corporation (the "Corporation). The name under which the Corporation was organized is The Victory Reinsurance Company of America, Inc.

SECOND: The Department of State filed the Certificate of Incorporation on May 22, 1980.

THIRD: The Certificate of Incorporation is hereby amended to change the name of the Corporation to QBE Insurance Corporation. To accomplish the foregoing change, Article FIRST of the Certificate of Incorporation is deleted in its entirety, and the following Article is substituted in lieu thereof:

"FIRST: The name of the corporation is QBE Insurance Corporation."

FOURTH: The Certificate of Incorporation is hereby further amended to change the par value of the stock of the Corporation. To accomplish the foregoing change, the first paragraph of Article FOURTH of the Certificate of Incorporation is deleted in its entirety, and the following paragraph is substituted in lieu thereof:

"FOURTH: The Corporation shall have authority to issue two classes of stock, Common Stock and Preferred Stock. The total number of shares of Common Stock which the Corporation shall have authority to issue is Ten Million (10,000,000) shares, all of which shall have a par value of Fifty Cents (\$.50) per share, for an aggregate of Five Million Dollars (\$5,000,000.00). The total number of shares of Preferred Stock which the Corporation shall have authority to issue is One Million (1,000,000) shares, all of which shall have a par value of Fifty Cents (\$.50) per share, for an aggregate of Five Hundred Thousand Dollars (\$500,000.00). Each share of Preferred Stock shall be redeemable at par on the Corporation's demand out of legally available funds."

FIFTH: The above amendment to the Certificate of Incorporation was authorized by the unanimous written consent of the Board of Directors of the Corporation, followed by the written consent of the sole shareholder of the Corporation.
