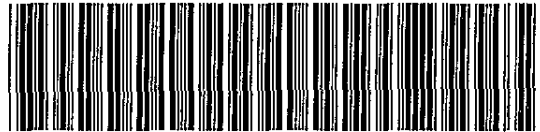




ARTICLE IX

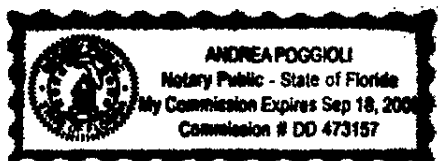
