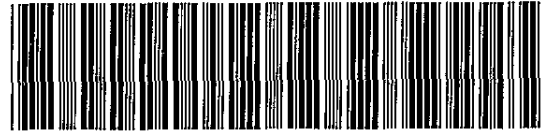

ARTICLE I - NAME

ARTICLE III - PURPOSE
