ARTICLES OF INCORPORATION
OF

ARTICLE I

The name of the corporation is "Suncoast Portable Sanitation, Inc."

ARTICLE II

The corporation has the authority, acting through its board of directors, to issue not more than one thousand (1000) shares of a single class having a par value of \$.01 per share which shall be referred to as "Common Stock." The Common Stock (a) shall be one and the same class, (b) shall have unlimited voting rights (with each share having one vote on each matter submitted to shareholders for vote), (c) shall have equal rights of participation in dividends and other distributions and (d) shall be entitled to receive the net assets of the corporation ratably upon dissolution.

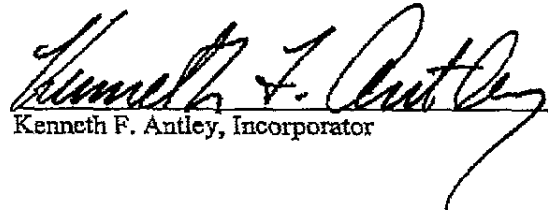

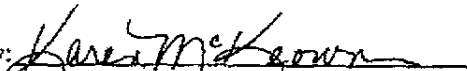
