**ARTICLES OF INCORPORATION
OF
SUNSTATE INVESTMENTS GROUP, INC.**

THE UNDERSIGNED, acting as sole incorporator of SUNSTATE INVESTMENTS GROUP, INC. under Chapter 607 of the Florida Statutes, hereby adopts the following Articles of Incorporation for such corporation:

**ARTICLE I
NAME**

The name of the corporation is SUNSTATE INVESTMENTS GROUP, INC.

**ARTICLE II
SHARES**

The total authorized capital stock of the Corporation shall be 10,000 shares of common stock, of which 100 shares shall be voting common stock, One Cent (\$0.01) par value per share, and 9,900 shares shall be non-voting common stock, One Cent (\$0.01) par value per share. Each share of the Corporation's common stock shall have the same rights and preferences as each other share of the Corporation's common stock, except that each share of the voting common stock shall be entitled to vote on all matters submitted to the shareholders of the Corporation and each share of the non-voting common stock shall not be entitled to vote on any matter.

**ARTICLE III
COMMENCEMENT OF CORPORATE EXISTENCE**

In accordance with Section 607.0203(1), Fla. Stat., the corporation's corporate existence shall be deemed to have commenced at 12:01 a.m. on January 13, 2006, or, if later, such time and date as is five business days prior to the date on which these Articles of Incorporation are filed by the Department of State.
