

### ARTICLES OF INCORPORATION OF THOMPSON POOLS AND SPAS, INC.

The undersigned acting as incorporator of this corporation pursuant to Chapter 607 of the Florida statutes, hereby forms a corporation for profit under the laws of the State of Florida and adopts the following Articles of Incorporation for such corporation.

#### ARTICLE I- NAME AND ADDRESS OF CORPORATION
